Subject: IGST Export Refunds – extension in SB005 alternate mechanism and revised processing in certain cases including disbursal of compensation cess - reg.

It is brought to the notice of all Member of Trade/ Industries/ Trade Associations and all others concerned that the Central Board of Indirect Taxes and Customs extended the rectification facility for all cases covered under Circular No.40/2018-Customs dated 24.10.2018 to Shipping Bills filed upto 31.07.2019 vide Cicular No.26/2019-Customs dated 27.08.2019 issued vide F.No.450/119/2017-Cus-IV.

All Field formation shall conduct outreach programmes to make all stakeholders aware about correct procedure for claiming IGST refunds so that repeated errors are avoided / minimized.
