Attention of all the Importer, Exporters, Customs Brokers, other stake holders and members of the trade is invited to the Special Drive "IGST Refunds Fortnight" beginning from 03<sup>rd</sup> September, 2019 to 18<sup>th</sup> September, 2019.

2. Board has decided to further intensify the efforts to liquidate all pending IGST refund claims by observing a Special drive "IGST Refund Fortnight" beginning from  $03^{rd}$  September, 2019 to  $18^{th}$  September, 2019. It will be observed across all the field formation wherein exclusive camps/ refund cells has been set up to deal with cases of pending export related refund claims. It has to be an effort to reach out to the exporters to help them overcome the obstacles in the processing of the refunds rather than waiting for them to knock our doors to get their dues.
