1. Bid Security of Rs. 10,000 –Rupees Ten Thousand only)_ in the form of Demand Draft/ pay Order payable to the 'AO, (DDO) Manik Bagh Palace, Indore MUST ACCOMPANY THE Bid. Bids without BID Security and in any other form i.e. cheque, cash etc. will NOT be considered.
 2. In the event of the last date being declared as a holiday/ closed day, the bids will be received/ opened on the next working day at the appointed time.
