Subject: - Extension of Special Drive "ITC Refunds fortnight" beginning from 31st May 2018 to 14th June 2018 upto 16th June 2018.- Regarding.

In continuation of this office Trade Notice No. 12/2018 dated 30.05.2018 it is informed that the Ministry of Finance, CBIC, New Delhi has decided to extend the special refund liquidation drive fortnight commencing from 31st May 2018 to 14th June 2018 till 16th June 2018. In view of overwhelming response from exporters and pending claims, the period of Refund fortnight is being extended by two more days i.e. upto 16th June 2018. The officers and staff would attend to all the issues pertaining to ITC refunds. During this period the offices shall remain open on Saturdays also.

2. All the constituent members of Trade Associations/ Chamber of Commerce and Industry/Members of Regional Advisory Committee/Public grievance Committee are requested to circulate and publicize the contents of this Trade Notice amongst their member constituents. The earlier Trade Notice no. 48/17-18 dated 16.11.2017 (issued on the basis of Circular No. 17/17/2017-GST dated 15.11.2017) and Trade Notice no. 53/17-18 dated 22.12.2017 (issued on the basis of Circular No. 24/24/2017-GST dated 21.12.2017) issued in the matter may also be referred to which is readily available on the website www.gstindore.gov.in

3. All GST refund claimants may note the refund application in FORM GST RFD-01A will not be processed unless a copy of the application, along with all supporting documents, is submitted to the Jurisdictional tax office. Mere online submission is not sufficient.

4. The exclusive camps /refund cell set up at all the divisions of this Commissionerate to deal with cases of pending ITC related refund claims would be functions upto 16th June 2018. All assesses are advised to contact the following nodal officers of the concerned divisions of their jurisdiction to resolve their issues related to ITC refund claims.
