Subject: - Refund Disposal Fortnight to handhold trade & industry in clearing pending GST Refund from 16.07.2018.to 31.07.2018-reg..

It has been decided by the Ministry of Finance, CBEC, to organize a special drives cum refund fortnight commencing from **16th July 2018 to 31th July 2018**. The officers and staff would attend to all the issues pertaining to ITC refunds. During this period the offices shall remain open on Saturday also.

All the constituent members of Trade Associations/ Chamber of Commerce and Industry/Members of Regional Advisory Committee/Public grievance Committee are requested to circulate and publicize the contents of this Trade Notice amongst their member constituents.
